Chapter 1. Introduction

The Introduction contains six "Guiding Principles" that help guide the Housing Element update. Do you agree with the guiding principles? Are there other principles that should be considered for the City of Yreka around housing?

The City held several public engagement opportunities for the Housing Element update. Did you attend any of the engagement events? Do you think there should have been other opportunities for engagement? What other types of engagement would you like to see?

The Introduction ends with a recommendation to collaborate with Siskiyou County and the other incorporated cities on the next Housing Element update in eight years. Do you agree that the City should collaborate or continue to develop our own Housing Element specific to Yreka?

Chapter 2. Goals, Policies, and Programs

What goals, policies, and programs do you feel are appropriate for the City of Yreka to support housing development in the next eight years?

What goals, policies, and programs do you feel miss the mark in terms of addressing housing development in Yreka?

Are there any goals, policies, and programs that you did not see that should be added to the Housing Element update?

Chapter 3. Previous Housing Element Analysis

Would you say that the City was successful in implementing the previous Housing Element goals, policies, and programs? Why or why not?

Do you agree with the goals, policies, and programs that are recommended to be continued or not continued in the next Housing Element?

Appendix A. Housing Needs Assessment

What data trends did you find interesting in the Housing Needs Assessment? Why?

What factors addressed in the housing needs assessment should take priority in the updated Housing Element?

Is there information you feel is not considered in the Housing Needs Assessment? Why should it be included?

Appendix B. Assessment of Fair Housing

The Fair Housing Assessment is a new requirement for Housing Element. It addresses potential segregation of race and ethnicity, disability, income, and familial status households. What is your feeling after reviewing this assessment?

In your opinion, what can the city do to foster an inclusive, fair community and housing market?

Do you agree or disagree with the information presented in the Fair Housing Assessment? Why?

What can the city do to ensure positive economic, social, and health outcomes for all of its residents?

Appendix C. Inventory of Sites

Do you believe the recommended site for future affordable housing should be a priority for the city? Why or why not?

What other sites within the city should be prioritized for affordable or workforce housing development?
